<i>F#</i>	ABS' authorization for MARPOL Data Collection System (DCS) includes the provision of DCS certification to ships classed by another RO of the flag Administration
<i>P</i>	Partial authorization (it is imperative to refer to the Administration-specific P/I for instructions): 1) to perform plan review and carry out surveys or audits where the Administration issues the certificates based on ABS Statement of Compliance or ABS interim certificate 2) to perform plan review, carry out surveys or audits and issue certificates for specific "types" of ships 3) provide full (F) certification in certain geographic locations 4) to issue certificates subsequent to the initial certificate issued by Administration
<i>L</i>	Limited authorization for categories not covered by "F" or "P" where a case-by-case authorization is needed by ABS.
<i>a</i>	An "a" with "F" or "P", indicates authorization for plan review required; Administration reviews specific plans; or "initial" survey/certificate carried out/issued by Administration.
<i>+</i>	Authorization is unique and independent of (Flag Administration)
<i>Y</i>	Indicates that the Administration is signatory to the IMO Instrument
<i>Blank Space</i>	Indicates that ABS is not authorized.
